Dr Julie Rugg

Reader in Social Policy at the University of York Topic: Social Justice and Cemetery Systems: some Reflections from Europe

Dr Julie Rugg is a Reader in Social Policy at the University of York, UK. She is a research fellow who routinely undertakes contemporary policy analysis, principally in the field of housing. She has also, since 1987, been active in researching the history and policy of disposing the dead in the UK and globally. She is an honorary Vice President of the Institute of Cemetery and Crematorium Managers. Dr Rugg is particularly interested in the ways in which communities make decisions about how to dispose the dead, and how leading rationales change over time. She has published on the ways in which - initially erroneous - understanding of the causes of disease led to the creation of cemetery management as a science. Graves were designed to absorb the supposed toxic emanations from decomposing bodies, and cemeteries were ordered to minimise impact on public health. In publishing on the history of burial in the UK in the 19th and 20th centuries, she has charted the operation of the highly arcane Burial Acts, defined the declining influence of the Church of England as a principal burial supplier and outlined the rise of cemetery management as a distinct profession. Dr Rugg has also published on the intersection between cemetery tourism and heritage. She is editor of the Routledge series reviewing funeral practice in different countries: texts have been produced on England and Wales, the Netherlands, Czech Republic, Serbia, Russia, and Portugal. This year, Dr Rugg has revised and republished the Cemetery Research Group website, which includes a fully interactive bibliography. Dr Rugg's more recent work has focussed how it might be possible to distinguish distinct 'cemetery systems' in each nation state. Attending the 2nd Pan-African Cemeteries-Crematoria Conference in 2019 has provoked a strong interest in the challenges facing cemetery management in African nations.
